Applications are invited from serving BSF Male and Female Constables(GD), Head Constables (GD), ASI(GD)) and Tradesmen (who meet QRs) for selection to the post of **Sub Inspector (GD)** in Border Security Force through LIMITED DEPARTMENTAL COMPETITIVE EXAMINATION (LDCE)-2018-19 in Pay scale as mentioned below. The post of Sub Inspector (GD) is Group 'B' Non-Gazetted, Non-Ministerial (Combatised). The posts are temporary but likely to become permanent.

- A. **Vacancies:-** The vacancies are subject to change which may increase or decrease. The category wise break up of the vacancies are as under:-

Note :- In case of non selection of required numbers of female candidates, same shall be filled by SI/LDCE (Male).

- B. **PAY SCALE:-** The post carries pay scale of Pay Metrix Level-6 (Rs. 35400-112400/-) and other allowances as admissible from time to time.

2. **Eligibility conditions:-**

Constables(GD), Head Constables(GD) and ASI(GD) will be eligible to appear in the said LDCE. Tradesmen, who meet QRs of SI/LDCE, are also eligible to appear in SI/LDCE.

- a) Service eligibility: They should have completed four years of service, including basic training.
- b) Upper age and : The upper age limit for appearing in the LDCE will be 32 years as on the closing date of Application. The required education qualification will be graduation, qualification which is also the eligibility for Direct Entry SIs.
- c) Clean record : They should have maintained minimum Good APARs grading of last four years and should have **“unblemished clean record of entire service until issue of offer of appointment”**.
- d) Physical Standards : As applicable to SI/DE candidates. The Physical standards of SI(DE) candidates are as under :-

Note : (i) There shall be no chest measurement for Female candidates.

(ii) Weight will not be disqualification at the stage of PET. However, it would be assessed for disqualification during medical examination w.r.t Height/Age Standard Chart.

(e) Medical category: SHAPE-1 (*Applications of candidates having low medical Category should not be entertained*).

3. **Number of chances admissible:-**

In all, three chances will be given to a candidate for appearing in the LDCE.

4. **Age Relaxation** : Relaxation of 5 years in age limit to the candidates belonging to SC/ST is permissible in accordance with the instructions issued by the Govt. of India from time to time. **The crucial date for determining the age limit shall be the closing date for receipt of applications.**

5. **Scheme of Examination**

Examination will consist written and physical tests as per the standard laid down by the Staff Selection Commission, as under:-

Stage-I : Checking of service records : No marks are allotted for stage-I. However, it should be ensured that candidates maintain Good APARs of last 04 years and unblemished service record of entire service.

Stage-II : Written Examination(OMR) based : There will be **one question paper of objective type multiple choice questions consisting of 200 marks with 3½ hours duration** to assess candidates in the following subjects on OMR system :-

1. General Intelligence and reasoning - 50 Marks
 2. Comprehension and communication skill - 50 Marks
 3. Numerical ability - 50 Marks
 4. General Awareness and professional knowledge - 50 Marks
- Total = 200 Marks

“For qualification/selection, a candidate shall secure atleast 45% marks in each part & 50% in aggregate. Relaxation of 5% marks will be given to the candidates belonging to SC/ST categories”.

Stage-III : Physical Measurements : As applicable to SI direct entry candidates. The minimum physical requirements for the candidates are mentioned at Para.2(d). ***No relaxation will be given in case a candidate has been appointed in lower rank with relaxed standard; such candidate will not be eligible to appear in the Sub-Inspector (GD) Limited Departmental Competitive Examination.***

Note :- Those candidates, who are not satisfied with the result of their measurements taken by the Board especially in case of height and chest, can prefer an appeal to the Appellate Authority of the Board on the same day and same venue of the PST/PET itself, if they so desire. Hence, the concerned RAs will detail an Appellate Authority who is senior than the Chairman of PST/PET Board to dispose of the appeals of the candidates on the last day of PST/PET. In such cases, the Appellate Authority of the board will again measure the physical standards of such candidates on the last day and the outcome of the measurement will be communicated to the candidate which shall be final and no further appeal or representation shall be entertained. Representation submitted at a later date shall not be entertained.

Stage- IV : Physical Efficiency Test(PET) : It will be of qualifying nature consisting of the following items :-

PET shall not carry any marks. The tests will be qualifying/elimination tests. *Failure in one of the events will amount to disqualification and will not be allowed to undergo further events.*

Stage-V : Medical Examination : Detailed medical examination of those candidates who come out successful in the written , PST & PET will be conducted, as per existing guidelines of the provision. Each candidate will be declared either 'Fit' or 'Unfit', and no one will be categorized "temporarily unfit".

7. **Guide lines for filling up the application form:-**

- a) The format of application is attached.
- b) The application of each individual duly filled in and supported with all required copies of certificates should reach the concerned Centre through proper channel.
- c) Applications received after due date will not be entertained under any circumstances.
- d) Covers containing the application must be super scribed in bold letters "**APPLICATION FOR THE POST OF SUB INSPECTOR (GD) THROUGH LIMITED DEPARTMENTAL COMPETITIVE EXAMINATION-2018-19,** and Centre of examination with Centre code.
- e) Candidates should apply through the concerned units/HQrs in which they are posted alongwith all required certificates as mentioned below:-
 - (i) **Application form** and **Admission card** duly filled in or duly typed on a full-scape paper.
 - (ii) Two passport size **photographs in uniform** are required. One each to be pasted on application form and admission card duly attested by a Gazetted Officer.
 - (iii) **Attested copies of certificates/testimonials** as proof of education qualification and date of birth i.e. matriculation, 10+2 and Graduation degree or provisional degree certificate with year wise all mark sheets.
 - (iv) SC/ST candidates should furnish attested copy of caste certificate in prescribed format issued by Revenue Officer not below the rank of Tehsildar. *Otherwise, their claim for SC/ST status will not be entertained and their candidature/applications will be considered under **General(UR)** category.*
 - (v) Copy of certificate in support of claim for relaxation in physical standards, if any.
 - (vi) An undertaking from candidate that he is willing to resign from present post in case he is selected for applied post as per proforma attached.
 - (vii) Service Certificate, as per proforma attached, to be signed by **Head of Office / Appointing Authority**.
 - (viii) Application in respect of following candidates **will not be forwarded** who have:
 - a) Not completed **4 years of continuous service as CT(GD), HC(GD) ASI(GD) or Tradesmen** including basic training as on the last date of receipt of application.
 - b) Not having **clean record of entire service**.
 - c) **Low medical category**.
 - d) **Less in education**.
 - e) **Already availed three chances** in this examination.
 - f) A candidate **appointed in lower rank with relaxed standard, prescribed for CT(GD)**.

Note :- Head of Office before signing the service certificate will ensure that no application of ineligible candidate is forwarded.

8. **Correspondence with the examination Centre:-** Candidate will not enter into any correspondence with the examination centre about their candidature except when there is a change in the address. No result will be supplied to candidates and no correspondence will be entertained by the examination centre. All communications with examination centre should contain the following particulars:-

- (i) Regt. No., Rank, Name.
- (ii) Application Registration No./Roll No. if allotted.
- (iii) Centre as per application.
- (iv) Address as per application.
- (v) Category to which the applicant belongs.

9. **Declaration of Result** – Result will be prepared centrally and intimated to all concerned centres by Pers Dte (Rectt Section) for wide publicity and information of candidates. Result will also be published on BSF Website i.e www.bsf.nic.in and IPP General Download.

10. **General Instructions**

- (i) Applications which are not on prescribed proforma or not accompanied by specified enclosures or incomplete or defective applications shall be summarily rejected. No representation or correspondence regarding such rejection shall be entertained under any circumstances.
- (ii) Candidates are **not required to submit any original certificates** in support to their claims regarding educational qualifications and other relevant certificates and will submit only certified true copies alongwith their applications. They should, therefore, ensure that they fulfill all the eligibility conditions before filling in their application forms.
- (iii) Admission to the tests will be purely provisional. On verification at any later stage, if it is found that they do not fulfill any of the eligibility conditions; **their candidature will be cancelled.**
- (iv) All candidates who apply in response to the advertisements before the closing date and are found eligible will be assigned with Registration/Roll numbers by the concerned examination centre. They will be communicated through call letters for written test by concerned centre.
- (v) Admission card for written examination indicating time table and venue of the examination will be issued by concerned examination centre on hearing from Pers Dte (Rectt Section).
- (vi) Corrections in application, if any, should be legible and attested by the candidate.

- (vii) Before filling in the application form, the candidates should **read the eligibility conditions for the recruitment carefully** to see if they are eligible. They should apply only if they fulfill all the conditions to avoid disappointment at later stage.
- (viii) Applications which are not legible, incomplete, incorrectly filled or not accompanied by prescribed enclosures shall be summarily rejected.
- (ix) No changes in the entries once made in the application form will be allowed under any circumstances.
- (x) The candidates are advised in their own interest to ensure that the applications should reach the examination centre on or before the closing date **i.e. 26th October, 2018** positively. Applications received in the concerned centre after the closing date will not be entertained.
- (xi) **The decision of the selection board shall be final in all respect.** It is also intimated that success in the examination will not confer any right to appointment unless Competent Authority is satisfied that the candidate is suitable in all respects for appointment to the post.
- (xii) **Selection board shall not be liable for any claim arising out of any injury etc.** suffered during the tests.
- (xiii) **Candidates will have to appear at their own expense for these tests and no TA/DA journey expenses are allowed for attending the test. The period of the test will be treated as on leave for the candidates appearing in the test, which would be sanctioned by the leave sanctioning authority.**
- (xiv) Candidates are not permitted to use Mobile Phone, Calculator or any other electronic/electrical device for answering any paper (Test Booklets). Candidate must not, therefore, bring Mobile Phone, Calculator or any other electronic/electrical device inside the Examination premises. Possession of these items, whether in use or not, will be considered as "use of unfair means" in the Examination and appropriate action may be taken by the Concerned Centre against such candidates.
- (xv) This HQ will not take cognizance of representations, regarding the content of the Question Paper received later than fifteen days after the Examination.
- (xvi) All candidates be directed to fill and shade, name, roll number, date of birth, category and question booklet series code given in the OMR sheet because these information are essential for evaluation of the answer sheet. Ovals as printed against each should be shaded properly, otherwise OMR sheets of candidates may not be checked and declared fail for which candidate will himself be responsible for such mistakes. No change/ cutting/ overwriting is permitted. Correction fluid should not be used. Hence the ovals should be filled carefully.
- (xvii) Selected candidate should be medically Fit (SHAPE-I) till the joining/report at training centre for BRT.

11. **RESOLUTION OF THE TIE CASES:**

In case where more than one candidates have secured equal marks, the tie cases will be resolved by applying following methods one after another till the tie is resolved:-

- a) Total marks in the written examination.
- b) Date of Birth, with older candidates placed higher.
- c) Alphabetical order in which the first names of the candidates appear.
