If performance is not satisfactory, contract will not be renewed & can be terminated at any time without prior notice. - 6) Age criteria will be relaxed by 5 years for existing NHM employee.
- 7) For MBBS Qualification candidates, service under NHM is considered for bond issued by Director Medical Education / Dean GMC

- 9) Age criteria: for MBBS & Specialist 70 year, Nurses & Technicians 65 years, and for other staff Open category is 38 years & for reserved categories is 43 years.
