- NOTE: (i) The candidate may apply for pay matrix level -2 (GP ₹ 1900/-) or pay matrix level-1 (GP ₹ 1800/-) or both.
(ii) Separate examination will be conducted for the posts having Pay of Level- 2 & Level-1.

1.1. **Reservation** : The posts against this quota are open to all candidates and candidates belonging to SC/ST/OBC categories who apply against this quota will be extended relaxation in age limit and application fee as admissible in general open market recruitment. However, in case of being selected with any relaxation on account of being a candidate from the above categories, he/she will be taken against reserve roster point.

2.2 Minimum Scout and Guide Qualification:

The following qualifications are mandatory for recruitment of Scout & Guide posts in both Level-1 and Level-2:-

- (a) A President's Scout/Guide/Rover/Ranger **OR** Himalayan Wood Badge (HWB) holder in any section.
- (b) Should have been an active member of a Scouts organization for the last 5 years. The 'Certificate of Activeness' should be as per **Annexure-A**, and
- (c) Should have attended two events at National level **OR** All Indian Railways' level
- (d) Should have attended two events at State level.

2.3. Educational Qualifications: Candidates should possess requisite minimum educational qualification as on the **Date of issue of Notification**.

Those who are appearing at and/or awaiting results of final examination are not eligible:

3.. Application Fee.

Candidates should submit application fee for an amount mentioned below :

*Minorities include Muslims, Christians, Sikhs, Buddhists, Zoroastrians (Parsis) and Jain.

For claiming exemption/refund from the examination fee, minority community candidates should **upload, 'self-declaration'** as mentioned in **Annexure-E** at the time of filling up of online application.

Note: (i) Certificate in proof of the above issued by the authorities authorized to issue such certificate should be enclosed along with the application form for getting relaxation in the application fee. Candidates should check their eligibility thoroughly before applying.

(ii) Fee in respect of candidates, who are in-eligible shall not be refunded.

(iii) Candidates applying for both the posts have to pay twice the amount.

3.2. Procedures for payment of examination fees:-

- Payment will have to be made online through payment gateway as part of online application process.
- The payment can be made by using debit card / credit card / Internet Banking / e-wallets, etc. by providing information as asked on the system.
- For online payment/refund, transaction charges, if any, will be borne by the candidate.
- If the online transaction is not successfully completed, please login again and make payment for the same.

3. Documents required for applying ONLINE:

Before filling of online application, candidates are advised to keep scanned copy of following documents ready with them:

3.1 Photograph and signature (jpg/jpeg format having file size 20kb -50kb)

- i) Recent Passport size photograph with clear front view of the candidate's face.
- ii) Specimen signature.

3.2 Certificates (pdf format having file size 50kb-200kb):

- i) Copy of self attested certificate in proof of date of birth (Matriculation/10th Certificate),
- ii) Educational qualification: 10th/12th /ITI/NAC certificates and marksheet to be merged into a single pdf and uploaded

- iii) Caste certificates (SC/ST/OBC with declaration)
- iv) Scouting qualification certificate (Rashtrapati Scout/Guide/Rover/Ranger OR HWB Scout/ Guide/ Rover/Ranger),
- v) Certificate of active membership of a Scouting/Guiding group for last five years issued and signed by Group Leader (S/G), Dist. Organizing Commissioner (S/G), Dist. Commissioner (S/G) {as per Annexure- 'A'.}
- vi) Duly filled Annexure-'F' regarding details of Scouting events along with supporting certificates merged into single pdf shall be uploaded. Candidates will be required to submit details of national events attended (maximum-4), state events attended (maximum-4), specialization courses attended (maximum-2) and district events attended (maximum-3). Only the above mentioned certificates regarding details of Scouting events shall be verified during document verification and no other certificates will be entertained.

4. Procedure to be followed for applying online:

4.1 Candidates are required to apply ONLINE by visiting www.rrcbbs.org.in

Detailed instructions for filling up ONLINE applications will be available on the website.

4.2 Candidates are required to click on the link provided for filling ONLINE applications and fill up the personal details/BIO- DATA etc carefully.

NOTE-I: Candidates should ensure that their name, father's name, date of birth is exactly as recorded in Matriculation or equivalent certificate. Any deviation found during Document Verification will lead to cancellation of candidature and also debarment.

NOTE-II: Candidates are advised to indicate their active mobile number and valid e-mail ID in the ONLINE application and keep them active during the entire engagement process as all important messages will be sent by email/SMS which will be treated as deemed to have been read by the candidates.

6. INVALID APPLICATIONS:

The applications having any of the following deficiencies/discrepancies or irregularities will be summarily rejected:

- i) Application without proper scanned photograph and signature.
- ii) Application without proper certificates, in respect of date of birth, educational/ scouting qualifications
- iii) Caste (SC/ST/OBC & OBC declaration) certificate and other certificates should be obtained from the appropriate authority in the prescribed format.
- iv) Any other deemed irregularity.

7. SELECTION PROCEDURE:

7.1 Stages of recruitment:-

The recruitment will be based on following two stages:-

- a) Written Test.
b) Marks on certificate.

7.2. Candidates to the extent of only 5 times of the vacancies, who have scored minimum 35% marks in the Written Test, shall be shortlisted for certificate verification for awarding marks on certificates. The merit list of Written Test shall be criterion for short listing of the candidates for next stage of recruitment. .

7.2 SYLLABUS FOR THE WRITTEN TEST (FOR BOTH Level-1 and Level-2 POSTS):

History of Scouting/Guiding; Law & Promise; Organization – ‘District & State Level’; Training Centre – District & State Level; Knowledge of Books; Scouting for Boys/Guiding for Girls in India; Motto left hand shake; Salute; Prayer; Flag Song; National Anthem; Know the National and Scouting Flags; Social Services at various occasions; Hiking; Proficiency badges. How these are earned?; Stages in Scouting/Guiding. Thinking Day; Progressive Training of Scouts/Guides/Rovers/Rangers; Pioneering; Handicraft; Indian Railway Jamborette; National Jamboree; Jamboree on the Air. Organization at National Level; National Training Centers; WAGGGS/WOSM Uprashtrapati Award Competition; Prime Minister Shield Competition; Community Development Programmes; Aims and Methods of Scouting; How scouting is useful in producing better citizen?

7.3: The **date, time and venue** of written examination and certificate verification will be fixed by the RRC and will be intimated to the eligible candidates in due course. Request for postponement of the examination/document verification will **not** be entertained under any circumstances.

8. Terms and conditions for claiming age and application fee relaxation:-

(i) Candidates belonging to SC/ST communities should upload a duly scanned community certificate issued by the officer not below the rank of TAHSILDAR or equivalent.

(ii) Candidates belonging to OBC community should upload a duly scanned community certificate in the format given in Annexure-B of this Notification, In addition the OBC candidates should enclose self-declaration of non-creamy layer status in the proforma given in Annexure-C.

(iii) Serving employee and Staff of Quasi administrative offices of Railway organizations: "No Objection Certificate" and "Bonafide Certificate" giving the length of regular service etc. from the employer should produce at the time of document verification failing which their candidature will be cancelled.

(iv) Divorced/Judicially separated Women: Copy of Decree from the competent court of law for having divorced/judicially separated along with an Affidavit that she has not remarried, should produce at the time of document verification failing which their candidature will be cancelled..

(v) Widow: Death certificate of her husband together with an Affidavit to the affect that she has not remarried since should produce at the time of document verification failing which their candidature will be cancelled,

(vi) Ex-Servicemen: Discharge certificate should produce at the time of document verification failing which their candidature will be cancelled.

(vii) Persons with Disability should produce the disability certificate at the time of document verification failing which their candidature will be cancelled.

(viii) Candidates belonging to economically backward classes mean the candidates whose family income is less than 50,000/- per annum. The following authorities are authorized to issue income certificates for the purpose of identifying economically backward classes:

a) District Magistrate or any other Revenue Officer up to the level of Tahsildar,

b) Sitting Members of Parliament of Lok Sabha for persons of their own constituency.

c) Union Minister may also recommend for any persons from anywhere in the country"

d) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.

Note: BPL Card or any other certificate issued by Central Government under a recognized poverty alleviation Programme or Izzat MST issued by Railways will also be valid. The format of Income certificate to be scanned and uploaded by the candidates of economically backward classes as annexed at Annexure-'D',

8. OTHER TERMS AND CONDITIONS :

- (i) Eligibility status, call letter, result etc. of the candidate shall be made available on RRC/BBS website i.e rrcbbs.org.in.
- (ii) Applications not fulfilling any of the terms and conditions given in this notification shall be summarily rejected.
- (iii) Discrepancies in the application submitted would render the candidate ineligible at any time during the selection.
- (iv) Selected candidates have to pass the requisite medical fitness standards prior to appointment.
- (v) In the event of appointment as Clerk-cum- typist posts in Group-C railway service, candidates will be required to acquire typing proficiency of 30 w.p.m. in English or 25 w.p.m. in Hindi within a period of two years from the date of appointment, and till such time, appointment will be provisional.
- (vi) Decision of East Coast Railway in all matters relating to this recruitment shall be final.
- (vii) The candidates applying against this notification should keep track of the Date of Written Test / Practical Demonstration which will be notified through the official website of RRC/BBS.
- (viii) Selected candidates are likely to be posted anywhere on East Coast Railway after successful completion of all pre-appointment formalities, including training wherever prescribed.
