RECRUITMENT TO THE POST OF LECTURER IN GOVERNMENT COLLEGE OF PHYSICAL EDUCATION IN GROUP-B UNDER SPORTS AND YOUTH SERVICES DEPARTMENT.

Online applications are invited from the prospective candidates through the Proforma Application to be made available on the WEBSITE (<http://opsc.gov.in>). The link for registration/re-registration and payment of examination fee shall be available from **09.10.2020 to 09.11.2020 (Note- 16.11.2020 is the last date for submission of Registered Online Application)** for recruitment to 05 (Five) posts of Lecturers in Physical Education in Group-B, under Sports & Youth Services Department, in the scale of pay of Rs.9,300-34,800/- carrying grade pay of Rs.4600/- in Level-10 of pay matrix under ORSP Rules-2017 with usual Dearness and other allowances as may be sanctioned by the Government of Odisha from time to time.

2. **VACANCY POSITION:** As per requisition filed by the Sports & Youth Services Department, the vacancy position along with reservation thereof is given below:

The number of vacancies to be filled up on the basis of this recruitment is subject to change by Government without notice depending upon the exigencies at the discretion of the Government.

3. **AGE:** A candidate must be under 32 (thirty two) years and above 21 (twenty one) years of age on the 1st day of January, 2020 i.e. he/she must have been born not earlier than 2nd January, 1988 and not later than 1st January, 1999.

Provided that the upper age limit shall be relaxable by 05(five) years for Scheduled Tribe candidates, Women & Ex-servicemen.

SAVE AS PROVIDED ABOVE, THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED.

Date of birth entered in the High School Certificate or equivalent Certificate issued by the concerned Board/Council will only be accepted by the Commission.

NOTE:- Candidates should also note that once a Date of birth has been claimed by them and entered, in the records of the Commission for the purpose of admission to an examination, no change will be allowed subsequently on any grounds whatsoever. If, on verification at any subsequent stage, any variation is found in their date of birth from the one entered in their High School Certificate or equivalent certificate, the candidature of the candidate concerned, will be rejected and or she/he may be debarred from present and future recruitments.

4. EDUCATIONAL QUALIFICATION:

A candidate must have possessed a Master's Degree in Physical Education (M.P.Ed.) with 55% of marks or its equivalent grade from a recognized University in India.

5. PLAN OF EXAMINATION:

(a) The recruitment examination for the posts of Lecturers in Physical Education will consist of the following successive stages:-

- (i) Written Examination;
- (ii) Viva Voce Test.

(b) The written examination will be in **General English, General Knowledge and concerned subject**. General English (Part-A) and General Knowledge (Part-B) will be covered in one paper carrying **100 marks** with 50 marks for each part. The examination in the **concerned subject** will be for **400 marks** consisting of two papers, i.e. Paper-I and Paper-II having 200 marks for each paper. **Each paper will be of 3 hours duration.**

(c) The candidates shall be called for interview by the Commission in order of merit equal to 03 times the number of vacancies if the vacancies are up to 50 and such numbers not less than twice and not more than thrice the number of vacancies as the Commission may determine, when the vacancies exceed 50.

Provided that for the vacancies up to 2, ten candidates and for the vacancies between 03 to 05, fifteen candidates shall be called by the Commission for Viva Voce test.

(d) The Commission shall conduct the **Viva Voce Test** for **50 marks**.

(e) **The Commission shall be competent to fix-up the qualifying marks in the Examination and Viva Voce.**

(i) The details of the syllabus is appended to this advertisement at **Annexure-A.**

6. EXAMINATION FEE :

A candidate is required to pay a non-refundable and non-adjustable fee of Rs.500/-(Rupees five hundred) only. Candidates belonging to Scheduled Caste/Scheduled Tribe of Odisha by birth only are exempted from payment of this fee.

The candidates are required to make Online payment of applicable Examination Fee(s) through OPSC portal using Debit Card/Credit Card/Net Banking facilities and other financial instruments enlisted in the Payment Page/Gateway of the Odisha Government Treasury Portal. The fee(s) paid shall neither be refunded under any circumstances nor can be adjusted or held in reserve for any other examination or recruitment.

7. PLACE OF EXAMINATION :

The written examination will be held at Cuttack. It may be held at Balasore, Berhampur, Bhubaneswar & Sambalpur depending on the number of candidates from the respective Zones. The candidates are to mention their choice of examination zones at appropriate place in the on-line application form.

8. OTHER ELIGIBILITY CONDITIONS :

- (i) The candidate must be a citizen of India;
- (ii) The candidate must be able to speak, read and write Odia and must have passed either the Middle School standard language test in Odia conducted by the Director of Secondary Education, Odisha or the Matriculation (Class-X/ 10th standard) Examination with 'Odia' as a subject.
- (iii) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- (iv) Government servants, whether temporary or permanent, are eligible to apply provided that they possess the requisite qualification and are within the prescribed age-limit as provided under Para-3 & 4 of the Advertisement. They must inform their respective Heads of Offices in writing regarding submission of their applications for this recruitment and obtain "No Objection Certificate";
- (v) If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or other State Public Service Commission or U.P.S.C. from appearing at any examination/interview, he/she will not be eligible for such recruitment for that specified period/chance(s);

- (vi) Only those candidates, who possess the requisite qualification & are within the prescribed age limit etc. by the closing date of submission of online application, will be considered eligible;
- (vii) The candidates must be very much careful to fill-up and darken his/her Roll No, Question Booklet Series in the Answer Sheets and also to fill-up Question Booklet Series, Question Booklet Serial Number and Answer Sheet Serial Number in the Attendance Sheets carefully and correctly. Wrongly filled up Answer Sheets are liable for rejection.
- (viii) A candidate must have good moral character. Also he/she must be of good mental condition and bodily healthy and free from any physical defect likely to interfere with the discharge of he/her duties as an officer of the Service/Posts.
- (ix) Every candidate selected for appointment shall be examined by the Medical Board. A candidate, who fails to satisfy the Medical Board, shall not be appointed;
- (x) A candidate who claims change in his/her name after having passed the High School Certificate Examination or equivalent examination, is required to furnish copy of publication of the changed name in local leading daily newspaper as well as copy of notification in the Odisha Gazette in support of his/her change of name.

9. **OTHER CONDITIONS :**

- (i) A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or applying pressure on any person connected with the conduct of the recruitment process or found indulging in any type of malpractice in course of the selection or otherwise, shall, in addition to rendering himself/herself liable to criminal prosecution, be disqualified not only for the recruitment for which he/she is a candidate, but also may be debarred, either permanently or for a specified period, from any recruitment or selection to be conducted by the Commission;
- (ii) The provisions of the Odisha Conduct of Examination Act 1988 (Odisha Act-2 of 1988) are applicable to the examination conducted by the Odisha Public Service Commission. Any violation of the above Act and violation of "**instructions to candidates**" (as provided in the advertisement, application form, Brochure, Admission Certificate & Answer Script etc.) will be seriously viewed and disciplinary action will be taken against the concerned candidates as deemed proper.

- (iii) Applications submitted to OPSC if found to be incomplete in any respect are liable to rejection without entertaining any correspondence with the applicants on that score.
- (iv) Admission to Examination/Viva Voce will be provisional. If on verification at any stage before or after the examination/viva voce, it is found that a candidate does not fulfil all the eligibility conditions, his/her candidature will be liable to rejection. Decision of the Commission in regard to eligibility or otherwise of candidate shall be final.
- (v) This advertisement should not be construed as binding on the Government to make appointment.
- (vi) **Concessions meant for SC & ST by Birth are admissible to the Scheduled Caste and Scheduled Tribe of Odisha only.**
- (vii) The posts are Temporary and likely to be Permanent. The period of probation is two years from the date he/she actually joins in the post and may be extended at the discretion of the Govt. The appointment can be terminated on one months notice from either side without assigning any reason thereof.
- (viii) Candidates are required to take due care to annex with the printout/hard copy of online applications, the copies of certificates and other documents as stated under Para-10 of this advertisement.
- (ix) No one will be admitted to the examination centre unless he/she holds a certificate of admission. The eligible candidates are required to download their admission certificate from the website of Commission and produce the same before the Centre Supervisor for admission to the Examination Centre.
- (x) All persons appointed under the Government of Odisha on or after 1st January, 2005 shall not be eligible for pension as defined under sub-rule(1) of Rule-3 of the Odisha Civil Service (Pension) Rules, 1992; but shall be covered by the defined Contribution Pension Scheme in accordance with the Odisha Civil Service (Pension) Amendment Rules, 2005.
- (xi) Any misrepresentation or suppression of information by the candidate in the online application, will result in cancellation of the candidature or penalty, as decided by the Commission be imposed on the candidate.
- (xii) Mere empanelment in the select list shall not confer any right for appointment unless the Government is satisfied after making such enquiry as may be deemed necessary that the candidate is suitable in all respects for appointment to the service.

10. **CERTIFICATES/DOCUMENTS TO BE ATTACHED:**

Candidates, those who qualify in the written examination are required to bring with them the hard copy of online application form, along with true copies of the following certificates/documents/mark sheets etc. duly attested by the candidate along with originals of the same for verification of their eligibility as per terms and conditions of the advertisement, the date of which will be notified later in due course, failing which his/her application will be rejected for the said post. **The candidates are also required to mention on each document "submitted by me" and put their full signature on the same. They must not attach original certificates to their applications.**

- (i) H.S.C. or equivalent certificate in support of declaration of age issued by the concerned Board/Council;
- (ii) Intermediate/+2 Examination Certificate or equivalent Certificate issued by the concerned Board/Council;
- (iii) Bachelor's. Degree Certificate from recognized University;
- (iv) Master's Degree Certificate issued by the recognized University;
- (v) Mark-lists in support of all aforesaid Examinations passed (i.e. H.S.C. to Master's. Degree) including fail marks if any, issued by the concerned Board/Council/University;
- (vi) Two character certificates in original issued by two respectable persons, one of which must be a Government Servant not below the rank of Group-B.

NOTE - (a) Candidates who have not been awarded percentage of marks, but only "GRADE MARKS", should, along with their applications, produce the conversion certificate from the concerned University indicating the actual equivalent percentage of marks and the conversion formula failing which, their applications are liable to be rejected.

(b) While filling up the relevant box of the online application form, the candidate has to mention details of marks secured in annual examination leading to award of Degree (excluding the marks secured in the Extra Optional Subjects).

- (vii) Two recent passport size photographs(unsigned & unattested) which has been uploaded with online application in printout/hard copy of online application form.
- (viii) Certificates of conduct from the Principal/Proctor/Dean or Professor in charge of a Department of Teaching of the College or University in which he/she last studied;
- (ix) Caste Certificate by birth in support of claim as S.C./S.T., wherever applicable.

- (x) No Objection Certificate from the competent authority in case of Government Servants.
- (xi) Required pass certificate in Odia language in M.E. School Standard or HSC examination.
- (xii) Discharge Certificates issued by the Commanding Officer of the Unit last served; Ex-Servicemen must submit an Affidavit undertaking that he has not been appointed against any civil post after retirement from Military service, wherever applicable.
- (xiii) Copy of pay in slip in support of payment of fee.
- (xiv) If a candidate claims to possess qualification, equivalent to the prescribed qualification, the rule/authority (With number and date) under which it is so treated, must be furnished with the printout/hard copy of the online Application Form.
- (xv) The candidate must take utmost care in filling up marks secured and maximum marks for each year. Any mistake in filling up the marks will be at the risk of candidates.

NOTE-1 : (i) Candidates to be belonging to S.C./S.T. category by birth are required to submit copy of the relevant Caste Certificate as mentioned in their online application form and issued by the competent authority in the prescribed form.

(ii) Women candidates belonging to S.C./S.T. categories are required to submit Caste Certificates by Birth showing "daughter of". Caste Certificate by virtue of marriage (i.e. showing "wife of") are not acceptable and liable for rejection.

(iii) Community (Caste status) once mentioned by the candidates shall not be changed under any circumstances.

The competent authorities to issue caste certificates are: District Magistrate/Collector or Additional District Magistrate or Sub-divisional Magistrate/Sub-Collectors or Executive Magistrates or Revenue Officers, not below the rank of Tahasildar/Additional Tahasildar of Government of Odisha.

NOTE-2 Master's Degree Certificate, Caste Certificate, Odia Test Pass Certificate and Discharge Certificate of Ex-servicemen must have been issued by the competent authority within the last date fixed for submission of online applications form as indicated above.

11. GROUNDS OF REJECTION OF APPLICATION:-

Applications of candidates will be rejected by the Commission on any of the following grounds:-

- (a) In-complete online application form.
- (b) Non-submission of hard copy of online application form at the time of verification of original documents.
- (c) Declaration not signed (full signature) by the candidate in the hard copy of online application form.
- (d) Age limit of candidate not coming under Para - 3 of Advertisement
- (e) No required educational qualification as provided under Para - 4 of Advertisement.
- (f) Not furnished copies of certificates/documents/Mark sheet/ Conversion formula/Equivalent Certificate as provided under Para - 10 of Advertisement.
- (g) Odia Test (M.E. standard) not passed / Odia Test pass evidence not furnished as required under Para 8 (ii) of the Advertisement.
- (h) Non-payment of examination fee, (wherever applicable), as provided under Para - 6 of Advertisement.
- (i) The candidates rejected on the ground of non-payment of fees, may inform to the Office of the Commission within 07 days from date of rejection, failing which his/her case will not be entertained.
- (j) Submission of wrong information / false information about qualification / Age / O.T. Pass evidence / Category Status (S.T/ S.C/Women/Ex-servicemen etc.).
- (k) Suppression of facts / information about eligibility, if any.
- (l) Any other ground as per the decision of the Commission.

- (b) Candidates must apply online through the concerned Website of the OPSC <http://www.opsc.gov.in>. Applications received through any other mode would not be accepted and summarily rejected.
- (c) **Before filling up the online application form, the candidates must go through the following documents available at OPSC portal.**
 - (i) **Instructions to fill up online application.**

- (d) Candidates are requested to upload the scanned image of latest passport size photograph along with scanned image of his/her full signature and scanned image of Left hand Thumb Impression (LTI) in the online application form. Uploaded photograph, Specimen (full) signature and LTI must be clearly identifiable / visible, otherwise the application of the candidate is liable to be rejected by the Commission and no representation from the candidate will be entertained.
- (e) Candidates should keep at least two copies of latest passport size photograph which is uploaded to the online application form for future use.
- (f) On successful submission of the online Registration, an unique "Permanent Public Service Account Number (PPSAN)" will be assigned to the applicant. Applicants are required to take printout of the finally submitted online Registration/Re-registration and Application forms for submission to OPSC with ink signed signature and along with copies of requisite certificate & documents.
- (g) The candidates are advised to submit the Online Application Form well in advance without waiting for the closing date to avoid last hour rush.
- (h) Admission Letter for the eligible candidates to appear in the Examination shall be uploaded in the Website of the OPSC prior to the date of examination which will be published in the Website and Newspapers. The candidates are required to download their Admission Letter from the Website of the Commission and produce the same at the Examination centre for admission to the examination. PATTERN OF QUESTIONS

Paper-1

- All questions shall be compulsory. However, candidates shall have the option of selecting one out of three topics given for essay writing.
- The standard of questions in General English shall be that of High School (Class-X) Certificate Examination.
- Question requiring very short answer shall be asked in General Knowledge Paper.

Paper- 2 & 3

- Conventional questions requiring short and long answers.
- Each paper shall have eight questions out of which the candidates shall answer five questions.

A. PART – I :GENERAL ENGLISH & GENERAL KNOWLEDGE-100 MARKS.

GENERAL ENGLISH

The Question Paper in General English will be designed to test the candidate's understanding of English and workmanlike use of words. The pattern of questions would be as follows:

1. Precise writing of a passage of around 300 words : 10 Marks
2. Translation from Oriya to English : 10 Marks
3. Grammar, uses of Vocabulary : 15 Marks
4. Short Essay within 400 words. : 15 Marks

Total – 50 Marks

The standard of question of General English may be equal to Secondary Level (Class-X level).

GENERAL KNOWLEDGE

The paper in General Knowledge will include knowledge of current events and matters as of everyday observation and experience in the scientific aspects of life as may be expected of an educated person. The paper will also include question on History of India and Geography of such standard which the candidates should be able to answer without special study. Total 50 marks.
