- 3. Project duration is for 3 years. However, the selected candidates will be offered for one year and will be extendable based on the performance.
- 4. Interested candidates are requested to fill the online application. It is mandatory to fill the application online, and no other form of application will be accepted. Candidates are requested to arrange the softcopies of all the required documents before filling the application.
- 5. Candidates should read carefully the requisite minimum essential qualifications, age and eligibility, experience criteria etc. laid down in the advertisement before applying for the above post. Since all the applications will be screened on the basis of data submitted by the candidate in the online application form, the candidates must satisfy themselves of the suitability for the position to which they are applying.
