- 11) The date, time and venue of Screening Test, Seminar and interview will be informed only through the Institute website / registered e-mail of the applicant.
- 12) The invitation sent to the candidate for Screening Test, Seminar and interview merely indicates the suitability for the post and conveys no assurance whatsoever that he/she will be recommended or selected, or his/her conditions specified in the application will be accepted.
- 13) If the authorities decide to interview the candidate, he / she should arrange to be present at the venue fixed on the date and time specified at his / her own expenses. No TA/DA is admissible in this regard.
- 14) All certificates in original must be produced only at the time of interview for verification and also at the time of joining, if selected. If any candidate fails to produce any of the original certificates at the time of the interview, his/her candidature will be disqualified.
- 15) Canvassing in any form shall lead to cancellation of candidature.
